Through the Family Well Being Program, St Francis Center (SFC) offers weekly Pantry Services for families, youth, disabled adults, seniors, veterans and those living in supportive housing. Not only do guests benefit from groceries staff and volunteers distribute through the program, but the food pantry serves as a means to introduce families to SFC's other such as holiday adopt-a-family, nutritious cooking classes, health care, summer camps for youth and resource services. Combined these program offerings provide guests with the tools necessary to build better lives and neighborhoods.

4b (Code) (Expenses \$ 843,537. including grants of \$ 636,421.) (Revenue \$)

The Homeless Well-Being Program provides homeless guests with warm meals and sack lunches six days a week through the served meal service. Staff members also provide Health and Hugiene Services, Mail Service and Resource Services. SFC welcomed a community resource specialist to its staff in the beginning of 2012. The resource specialist provided comprehensive services beyond SFC's food programs, including referrals for health care services, shelter for families and individuals, assistance obtaining IDs for jobs and social security, and finding and placing guests in permanent, supportive housing. Individuals and families find themselves in search of help at SFC's doorsteps due to a variety of life-changing events, including job loss, addiction, illness or injury. The program is designed to end the cycle of poverty for

SFC's Youth Empowered for Success Program includes the After School Program, sports program, enrichment activities, and Youth Summer Camp Program. By offering year-round programs for the children of the very low-income families SFC serves through its Pantry Service, staff and volunteers aim to keep local youth off of the streets and engage them in activities that enrich their lives.
