ECONOMIC DEVELOPMENT - The economic development program of MaineStream Finance provides loans, education, and services to assist individuals to start small businesses and assist existing small businesses to grow The Incubator Without Walls program is a comprehensive training program that helps entrepreneurs advance their businesses through increased knowledge and skills in a multitude of business areas The program centers around group networking among participants rather than one-on-one business plan preparation or classroom work The program includes pre-loan technical assistance, such as writing a business plan, cash flow analysis preparation, and, after the loan has been processed, ongoing support for running a small business Business 101 classes are offered to prospective self-employed individuals and covers the basics of what it takes to start up a new micro-business Classes include financial review, budget and business cash flow counseling, assistance with a business plan, foreclosure counseling and debt management counseling Those businesses that are currently in operation are encouraged to attend the Incubator Without Walls program for classroom and networking support MaineStream Finance loans funds to day care providers that are used to establish/expand child care businesses in order to create job opportunities for low-income individuals
