U S Programs In 2012, SFP’s chapters launched their own local projects and also worked together on very significant national campaigns In January, for example, SFP organized the Martin Luther King Day of Service programs in 17 states, from Connecticut to California, and Florida to Washington D C , involving 21,090 volunteers in 354 service projects This was SFP’s seventh year as a lead agency with the Corporation for National and Community Service for the Martin Luther King Day of Service As a lead agency, SFP provides grants and support to communities throughout the nation Projects in 2012 targeted a range of social issues including hunger, literacy, poverty, financial education, and the environment

International Programs In 2012, SFP conducted seven major service projects, in the Dominican Republic, Guatemala, Honduras and Kenya, under the title Global Peacemakers (GPM) These programs, involving international volunteers, last from 10-14 days, and are designed to improve the quality of life in impoverished communities while also providing opportunities for personal development and learning among the volunteers For example, La Repressa, a rural community in the Dominican Republic, hosted a GPM program in July 2012 with 13 volunteers participating This program was held in conjunction with the University of California, San Diego (UCSD), United States,as part of its Alternative Breaks program The project focused on addressing seasonal flooding issues in the village by raising a levee along the river that flows through the community
