THREE YEARS INTO THE SNAP PROGRAM, TWELVE FARMERS MARKETS ARE CURRENTLY ACCEPTING SNAP OR HAVE BEGUN THE PROCESS TO ACCEPT SNAP BENEFITS. TWO ADDITIONAL MARKETS ARE PLANNED. CAPITAL RC&D ALSO SUPPORTS PROGRAMS TO HELP CONNECT LANDOWNERS WITH FEDERAL, STATE AND LOCAL PROGRAMS TO SUPPORT CONSERVATION ON THE LAND. PROGRAMS INCLUDED PROVIDING TECHNICAL STAFF TO COUNTY OFFICES THROUGH THE EWP AND SOIL CONSERVATIONIST PROGRAMS. THESE TECHNICAL STAFF WORKED WITH LANDOWNERS TO SUPPORT THE IMPLEMENTATION OF CONSERVATION PROJECTS FUNDED BY NRCS AND BY STATE AND FEDERAL FUNDS FROM THE EMERGENCY WATERSHED PROTECTION PROGRAM. A DATABASE DEVELOPED BY CAPITAL RC&D ALSO DIRECTED USERS TO MULTIPLE PROGRAMS TO SUPPORT SOIL AND WATER CONSERVATION. FURTHER, A CAPITAL RC&D PROGRAM SUPPORTED LANDOWNERS WITH CONSERVATION RESERVE ENHANCEMENT PROGRAM (CREP) CONSERVATION ACREAGE, AND OVER 100 LANDOWNERS WERE PROVIDED DIRECT TECHNICAL ASSISTANCE FOR MANAGING THEIR CREP ACREAGE. PROPERTY REVIEW WAS PROVIDED TO INDIVIDUALS WITH FARM OR NATURAL LAND UNDER FEDERAL LAND EASEMENT PROGRAMS INCLUDING THE WETLANDS RESERVE PROGRAM (WRP) AND THE FARM AND RANCLAND PROTECTION PROGRAM (FRPP).
