The Rhode Island Hospital Foundation (RIHF) provides philanthropic support to various programs at Hasbro Children's Hospital (HCH), the pediatric division of Rhode Island Hospital (RIH). Noteworthy in fiscal year 2012 were transfers of \$694,639 to HCH in support of its Child Life Program, which offers pediatric patients and their families opportunities for recreation, creativity, and diversion to provide a sense of normalcy during their hospital stay. The goals of HCH's Child Life Program are to (1) encourage children and adolescents to maintain a sense of independence, self-esteem, and control, (2) reduce the potential stress associated with the medical experience, (3) reestablish family routines, and (4) listen and advocate for family-centered care. Through the development and administration of philanthropic activities, RIHF is able to transfer funds raised to RIH to support its mission and purposes, which in turn benefit the Rhode Island community. In fiscal year 2012, RIHF transferred \$416,659 to RIH to help defray RIH's cost of installing new electrical switch gear in its Ambulatory Patient Center along with the purchase of a new emergency generator, renovations to the neurosurgery suite, and upgrading an inpatient oncology suite to accommodate high intensity patients. Also, in fiscal year 2012, RIHF transferred \$416,422 to The Warren Alpert Medical School of Brown University in support of shared chairs in cardiothoracic surgery, orthopedics, urology, emergency medicine, and oncology.
