Walk - Throughout the fiscal year GirlTrek hosted themed based walking challenges to inspire and support African American women and girls to live healthier, more fulfilled lives through walking In FY11, GirlTrek served approximately 10,000 women and girls and supported 179 Trek Teams in 39 cities across the country In FY 11 through the walk program, GirlTrek invested heavily in promotional materials, national and local advertising and a robust technological platform
