As Lead Agency of the Sarasota-Manatee Continuum of Care, the Partnership performed all required tasks and duties. The Partnership received a 90%+ customer satisfaction rating from member agencies. HOMELESS PREVENTION AND RAPID RE-HOUSING PROGRAM

The Partnership received, administered and provided data evaluation and reporting services for a federal HPRP (Homeless Prevention and Rapid Re-housing) grant, as subgrantee for Manatee County, and a Florida HPRP grant. The Partnership contracted with six (6) social services agencies to assist individuals and families that were homeless or at-risk of homelessness. Over 250 individuals and families were provided financial assistance through this grant, and HUD recognized the program with an Award of Excellence.

EMERGENCY SHELTER AND FINANCIAL ASSISTANCE:

The Partnership received, administered and provided data evaluation and reporting services for a Florida Challenge Grant and CDBG grant (as sub-grantee of a City of Sarasota Grant).
