

FINANCES:

All money paid to the Association shall be placed in a general operating fund. All events shall have a separate fund account and shall be closed after each event, with excess money transferred to general operating fund. Funds unused from the current year's budget and fundraiser will be placed in a reserve account and may be used as deemed necessary by the Board of Directors.

Except as the Board of Directors may generally or, in particular cases, authorize the execution thereof in some other manner, all checks, drafts, and other instruments for the payment of money and all instruments of transfer of securities shall be signed by two (2) Officers. No member of the executive committee of the Corporation shall be authorized to obligate or commit the Corporation to any single expenditure of the Corporation's funds in an amount exceeding \$1000, if not provided for within the budget or without prior approval of a majority of the Board of Directors.
