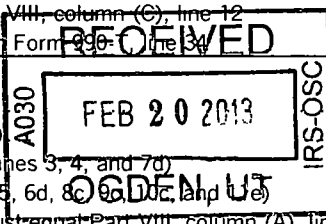

The Forrest General Healthcare Foundation (the Foundation) was established to support the promotion of health within the service area of Forrest General Hospital (the Hospital) and for the benefit of the Hospital. In doing that, the Foundation has embarked on a major capital campaign. This campaign will raise funds for the purpose of building a new inpatient Hospice House. Upon completion, the inpatient Hospice House will have 12 patient care rooms as well as many family support areas. In December, 2008, Foundation received a land donation valued at \$360,000 for the future home of the Hospice House.

The Foundation purchased NICU video monitors to allow parents of patients to see their child remotely when they are not able to physically be in the unit. Bottle warmers were purchased for the NICU unit and the final phase of the NICU renovation was completed.

Also, grants were made to the Hospital to purchase hospital wide telemetry equipment, EKG machines for the Emergency department and capital renovations for the Hospital facilities.

Jenny Pender Fund – a designated fund that was started in memory of Jenny Pender and is to be used in some way for the cardiac program at FGH

Tree of Life (Cancer Center) – a designated fund to help supplement and enhance the cancer program at the FGH Cancer Center

Public Safety Fund – a designated fund to help supplement costs associated with the Public Safety Program at FGH

3B Designated Fund – a designated fund to be used solely for purchases to enhance the care offered by the staff on 3B at FGH

Fund for Pediatrics – a designated fund to be used solely for purchases to enhance the care offered by the staff on the Pediatric wing at FGH

Designated Fund for Neurosurgery – a designated fund to be used solely for purchases to enhance the care offered by the staff in the Neurosurgery department at FGH

FGH Diabetes Camp at Twin Lakes – designated funds to help offset costs associated with the Diabetes Camp at Twin Lakes

Camp Bluebird – designated funds to help offset costs associated with the Camp Bluebird and offer camp Scholarships for those who wish to attend but cannot afford the tuition

Diabetes Education Scholars – a designated fund to offer patient scholarships to patients who cannot afford the Diabetes Education offered by FGH

Brick Campaign for the Spiritual Grounds – a designated fund started by the sale of bricks to be used as Walkway in the Spiritual Grounds project

Gentle Path at Pine Grove – a designated fund to be used solely for purchases to enhance the care offered by the staff at Gentle Path

Rehab – a designated fund to be used solely for the purchases to enhance the care offered by the staff on the Rehab unit at FGH

Pine Grove Women's Center – a designated fund to be used solely for purchases to enhance the care offered by the staff at Pine Grove Women's Center

Gentle Path Patient Scholarships – a designated fund to offer patient scholarships to patients who cannot afford their treatment at Pine Grove's Gentle Path Program

FGH Wellness Scholarships – a designated fund to offer patient scholarships to patients who cannot afford the cost associated with joining the FGH Wellness Program

Diabetes Camp Scholarships – a designated fund to offer patient scholarships to patients who cannot afford the cost of the Diabetes Camp at Twin Lakes

Doctor's Hall of Fame – a designated fund started from donations received for the Doctor's Hall of Fame The Foundation board has not determined the use of these funds as of yet

Cardio Pulmonary Rehab – a designated fund to be used solely for purchase to enhance the care offered by the staff in the Cardio Pulmonary Rehab unit of FGH

Steve Grimm Conference Room at HCH – a designated fund started to fund the naming of a conference room in the new Highland Hospital name after Steve Grimm

Rehab Piano Fund – a designated fund to assist with costs associated with maintaining the piano in the Rehab Unit

Cardiac Program at FGH Fund – a designated fund to assist with costs associated with cardiac related programs at FGH

FGH Medical Library Fund – a designated fund to raise monies to purchase books and related items that are needed in the FGH Medical Library

FGH Pastoral Services Fund – a designated fund established to offset the costs associated with items and programs needed by the Pastoral Department at FGH

Nursing Education Fund – a designated fund established to help offset the costs of obtaining educational materials and programs for the nurses at FGH

Pine Grove Next Step Fund – a designated fund established to help purchase items or enhance the care given at Pine Grove's Next Step Program

Employee Campaign Operations Fund – a fund established to help offset the costs of operations for the annual Employee Giving Campaign

Highland Catastrophic Assistance Programs for Employees – a designated fund to assist Highland Community Hospital employees

Golf Tournament Operations – a designated fund established for fund-raising activities related to golf tournaments. Funds raised are used for targeted projects and/or capital items at FGH (i.e. EKG machines for the ER)

NICU Video Monitors – a designated fund to assist with the purchase of video monitors in the Neonatal Intensive Care Unit (NICU)
