Food & GoodsEvery second Saturday of the month, 25 to 40 volunteers gathered to sort various items such as food, clothing, books, toys and furniture These items are labeled and cataloged They are then loaded into a tractor-trailer container and shipped to Jamaica In fiscal year 2011-12 we shipped 538 boxes or items of food and 1,297 boxes or items of clothing and goods An estimated 400 elderly poor receive food from the St Pius X Food Pantry twice per month In addition, we funded \$14,000 in food aid to St Pius X and St Martin de Porres Reported amounts include non-cash in-kind food valued at \$18,830 and other items valued at \$115,116

MedicalThe medical clinic at St Pius X in Kingston, Jamaica operates 4 days per week, with a part-time local physician who provides care on a deeply discounted basis The clinic is open to all indigent patients in the poor neighborhood of St Pius, regardless of ability to pay, or church affiliation We estimate an average 60 patients visit the clinic per week, i.e 3,000 per year Jamaica Outreach Program supplies the clinic with medicine and much-needed equipment The clinic dispensary supplies patients with medications free of charge In addition, Jamaica Outreach Program solicits donations of medicine from Catholic Medical Missions Board and their value is included in reported amounts Reported amounts exclude \$15,200 of non-cash in-kind medical services
