28	The National Immigrant Farming Initiative (NIFI) provided education, outreach, and technical assistance through the Risk Management Education and Outreach Partnerships Program to support Hispanic, New and Beginning Farmers in DonAna, Otero, and Luna Counties in southern New Mexico. Building on our recent experience organizing members of the agricultural community in New Mexico, NIFI provided targeted training on risk management tools including Specialty Crops, Irrigation, Erosion Control Measures, and Good Farming Practices to farmers located in the Colonias Border Region. NIFI contracted with a locally based consultant in Chaparral, NM to educate and provide technical support to members of the agricultural community that includes Women, Seniors, Hispanic, Socially Disadvantaged, and New and Beginning Farmers. The model developed and experience gained in Southern New Mexico has led NIFI to develop a model of Rural Prosperity and Participatory Farm Management that will replicated in Northern New Mexico and Southern Washington State.
