Market on the Move - Distribution of fresh produce through produce markets throughout Arizona. During the current fiscal year, almost 80,000 individuals received produce from these markets. Classes are also offered through this program to educate individuals about canning and dehydration techniques to extend the useful life of fruits and vegetables

American Medical Aid - Collecting, sorting, and distributing medical supplies and equipment to Organizations which assist individuals in need throughout North America, as well as providing financial assistance to Organizations working towards similar goals. Medical personnel donated specialized services resulting in our ability to salvage and subsequently donate almost \$7.3 million in medical supplies during the year. These medical supplies were donated to organizations in the US to support their medical programs. Due to the value of these items being the direct result of donated services, which are excluded for purposes of completing Form 990, the subsequent expense (grant) is also excluded. Both the income and the expense are reflected in the Donated Services adjustment on Schedule D, Parts XII

Feeding Children in America - Distribution of fresh produce through food banks to individuals and families in need. During the current fiscal year, more than 4,000 individuals were assisted through this food distribution. Medical personnel donated specialized services resulting in our ability to salvage and subsequently donate almost \$7.3 million in medical supplies during the year. Due to the value of these items being the direct result of donated services, which are excluded for purposes of completing Form 990, the subsequent expense (grant) is also excluded.
