CAVE AND KARST RESEARCH, MANAGEMENT, AND CARTOGRAPHY. The primary focus of the Foundation is assisting
government land managers who are responsible for caves and karst areas. Support includes inventorying caves and karst features,
developing management plans to protect these unique resources, performing biological and other inventories in the caves,
and systematically mapping the caves. Cooperative agreements are in place with Mammoth Cave National Park, Carlsbad Caverns,
Caverns NP, Buffalo River National Scenic Riverway, Mark Twain National Forest, Lava Beds National Monument, Sequoia-Kings
NP, and others. The Foundation has a pool of over 230 active volunteers who do most of the actual work under the guidance
of the various land managers. Over 17,000 volunteer hours were donated to the Foundation in 2011-12.
