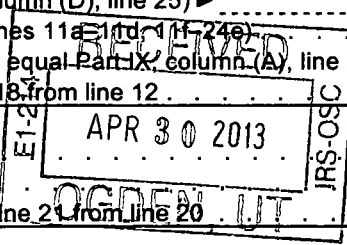

The project targets at-risk youth referred by teachers, counselors, law enforcement, and parents. Thirty-three AmeriCorps members annually mentor 528 young people.
