Child Prep and mentoring programs are a program mix of programs for youth in foster care, many with no identified permanent family who will likely "age out" of foster care The mentoring program called Permanency Champions, is designed to find long term mentor relationships for 50 youth in foster care Mentors support the youth and expose the youth to meaningful activities and help them move towards self-sufficiency Other Child Prep programs help youth to prepare for life after foster care including preparation for adoption or emancipation Programs include Get Real, Youth Speak Out and Digital Me's

Triad Services - This program provides information, support, and education for all members of the adoption triad (adoptees, birthparents, adoptive parents, siblings, and others) and professionals who serve them These services include a telephone helpline that responds to 4,000 calls annually, support and discussion groups with annual attendance of over 650, assisted in the completion of 46 searches done by our members this year as well as educational workshops, lending library, and other support opportunities
