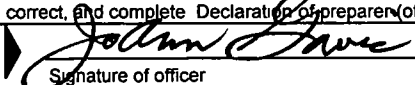
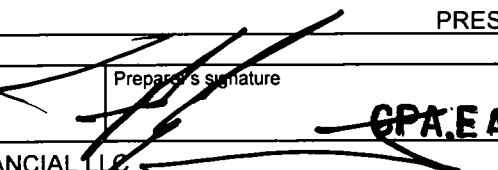

The hospitals and clinics provide much needed medical care to many of the needy and disadvantaged people of their areas. Some diseases are spreading at epidemic rates. The lack of properly equipped medical facilities and medical supplies further contributes to the ongoing challenge of saving lives. In addition the Organization works closely with representatives of these agencies to help respond to their on-going needs.

The Organization provides ongoing monetary grants to Destiny Medical Fund, which supports ongoing cancer projects at hospitals, clinics and institutions throughout the Philippines. The Fund distributes medical supplies and equipment to hospitals and clinics that treat cancer and other degenerative diseases. The Organization provides ongoing monetary grants to Oasis of Hope Hospital in Tijuana, Mexico. Oasis takes a total approach in treating individuals with breast cancer: spiritually, mentally, and physically. Oasis also promotes holistic cancer treatments that have proven to be effective. The Organization supports programs in Europe that help women with breast cancer thru research, prevention, early screening, and alternative treatments
