Form 990 Part X - In preparation of tax returns, tax positions are taken based on interpretation of federal, state and local income tax laws. Management periodically reviews and evaluates the status of uncertain tax positions and makes estimates of amounts, including interest and penalties, ultimately due or owed. Income taxes are not provided in the accompanying financial statements since the Agency is exempt from federal and state income taxes under Section 501(c)(3) of the Internal Revenue Code and similar state provisions. The Agency has evaluated the provisions of ASC Topic 740, Accounting for Uncertainty in Income Taxes. The Agency concluded that there are no significant uncertain tax positions requiring recognition in the Agency's financial statements. The Agency is not aware of any adjustments to the tax returns as filed, or is it aware of any claims for amounts owed from the taxing jurisdictions.

Form 990 Part VI, Section A, Line 10 - Review of Form 990. Community Action Agency's Form 990 is prepared by the Agency's Chief Financial Officer, who is a Certified Public Accountant, and reviewed by it's Chief Executive Officer. It is received and approved by the Agency's Finance and Audit Committee, and ultimately the full Board of Directors.
