Sponsorship of the child and Adult Care Food Program is the major activity of Child Care Choices, Inc. The agency holds a contract with the State of Minnesota to sponsor the program through the directives of the US Department of Agriculture(USDA). The program promotes proper nutrition for children in the care of licensed in-home child care providers by reimbursing them for a portion of their food costs for creditable meals.

Child care providers keep daily records of attendance and meals served to children in their care. The information is submitted to Child Care Choices on claims either electronically or on scannable menu reporting forms. The claims are reviewed for accuracy and allowable food served according to USDA regulations. The claims are submitted to the state for final processing. Payment is made to Child Care Choices for the grand total of claims and then payments are disbursed by Child Care Choices to each individual provider.

4b (Code:) (Expenses \$ 222,309 including grants of \$ 30,671) (Revenue \$ 410)
Child Care Choices, Inc. operates the resource and referral information program for the child care providers of Region 7W of Minnesota which includes Stearns, Benton, Sherburne and Wright Counties. The program promotes high-quality child care and helps parents locate licensed child care providers. The program also provides resources and tools to help individuals go into business for themselves as child care providers. Program also have components that offer services to families, friends and neighbors providing child care. All services are free of charge.

4c (Code:) (Expenses \$ 62,087 including grants of \$) (Revenue \$ 70,529)
Child Care Choices, Inc. hosts five conferences throughout the year to provide child care providers with the opportunity to receive education and training on issues affecting the child care profession. Child care providers receive creditable training hours that can be used to meet state licensing requirements. The conferences offer training on a variety of issues affecting all child care providers.

Child Care Choices, Inc. is required to make periodic unannounced visits to providers' homes to verify that the providers' records are up to date, that food items served qualify for reimbursement, and that children claimed are present. Child Care Choices also contacts parents of children periodically to verify that their children were in child care with the providers who are on the program. If any providers' records are incomplete, or if a child cannot be verified to have been in a provider's care, then Child Care Choices, Inc. is required to reduce the amount paid on a current meal claim or recover the amount from a previous meal claim.

Line 2: Child Care Choices, Inc. provides child care assistance to low income families. These funds are provided by the Otto Bremer Foundation. The funds are to pay for a portion of a family's child care expenses after deducting assistance provided by the state.
