3. The Charter of the Corporation is hereby amended by deleting the first sentence of Article I in its entirety and inserting in lieu thereof the following sentence:

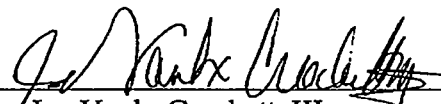
"The name of the corporation is Nashville Rescue Mission (hereinafter referred to as the "Corporation")."
