Esperanza De Vida, Zacapa, Guatemala- On April 23, 2012 the Organization provided medical supplies, mdical equipment and humanitarian aid worth \$685,652 to be used by those in need in hospitals and clinics in Guatemala. The hospitals and clinics provide much needed medical care to many of the needy and disadvantaged people of their areas, charging only the minimum amount, or in most cases nothing, for fees needed to provide the medical care. Medical supplies and equipment and nutritional supplements were provided to the Guatamala programs. Several thousands are helped each year.

4b (Code:) (Expenses \$ 41,000 including grants of \$ 0) (Revenue \$ 0)

Philippines Diabetes Research & Nutritional Center, Philippines - The Organization gave monthly grants to these programs to establish and maintain a medical and nutritional program for the treatment of diabetes and other life threatening diseases. The programs provided food, educational materials, medical supplies, and equipment to doctors, clinics, hospitals and individuals, who could not obtain them without financial aid. In addition, the programs provided for medical scholarships programs to assist individuals with the cost of attending nursing or medical schools, as well as conducting bi-weekly medical programs. 850 people were helped by these programs.

4c (Code:) (Expenses \$ 11,000 including grants of \$ 0) (Revenue \$ 0)

Destiny Medical Fund, Philippines - The Organization gave grants to support several medical projects at hospitals and clinics throughout the Philippines that treat cancer and other degenerative diseases. These programs support Vicente Sotta Memorial Medical Center and the Golden Center. Hundreds of patients are helped each year. Free cancer examinations are funded each month for patients in the province of Cebu. An educational TV program called the 'cancer show' is aired, seven days a week, on Sky Cable Network, reaching all homes in the province of Cebu. The programs distribute medical supplies and equipment to hospitals and clinics that treat cancer and other related diseases in the province of Cebu.
