 CMI inaugurated JacksonHole Live! as a series of six free concerts for the community during 2012. (Five of these concerts were held during the July 1-September 30 period.) The expenses of these concerts were funded in part by concessions and in part by sponsorships from the business community. Attendance ranged from 3,000 to 5,000 depending upon the performers and weather. However, community support for JacksonHole Live! could not have been stronger.

4b (Code:) (Expenses \$ \$60,000 including grants of \$ -0-) (Revenue \$ \$56,250)
 CMI sponsored a two week hockey camp for young skaters during August, 2012. Approximately 150 skaters participated in the camp conducted by coaches from Impact Hockey. Because CMI maintains dry floor events for conferences and conventions during most of the summer, major costs were incurred putting the ice in at the end of July and maintaining it in good condition during the camps. The Center was open for public skating during non-camp hours as well.

4c (Code:) (Expenses \$ \$58,000 including grants of \$ -0-) (Revenue \$ \$41,834)
 CMI hosted a number of conferences during the summer for groups that had previously booked through the prior operator of the Center. For example, the Wyoming Gas Fair was held during September over a four day period with over 500 attendees each day. This conference was a major event for the Jackson community and local merchants, hotels and restaurants due in part to CMI's efforts. However, the previously quoted pricing was inadequate to cover CMI's out of pocket costs for the event. Thus, while a major success, CMI faces major challenges in seeking additional support to host these events.
