Change by Us Change by Us is a partnership with the City of New York in which Citizens manages a micro-grant program for a multitude of neighborhood groups In addition to receiving financial support, projects are posted on the Change by Us online platform in order to attract and engage local volunteers Love Your Block Love Your Block is a special partnership between Citizens Committee and NYC Service that provides a unique opportunity for city residents to transform and beautify their neighborhoods and leverage City services Resident-led volunteer groups (grantees) receive a grant of \$1,000 to transform a city block Past Love Your Block grantees have received assistance with city services such as trash collection, vacant lot cleanup, graffiti removal, dead tree removal, tree planting, providing woodchip mulch for gardening projects, repair of and installation of street signs and street lights, traffic safety surveys, and more
