The American Center for Mongolian Studies is an academic organization promoting scholarship and research about and in Mongolia. The organization provides support services to students and faculty conducting study or research in Mongolia at its full service resource center and library in Mongolia. It also conducts a variety of public outreach and educational activities including lectures and language training.

Resource Center and Library in Mongolia: the organization maintains a fully staffed resource center and research library in Ulaanbaatar, Mongolia. The center is housed in the Mongolian University of Science and Technology library building and is overseen by a full-time Resident Director who is a US citizen. The Resident Director is supported by a full-time US Director hosted at the Center for East Asian Studies at University of Wisconsin-Madison. Primary support for the center comes from the US Department of Education, US Department of State, Henry Luce Foundation, and donations. The resource center offers visiting US and international scholars a comfortable research environment which includes computers, office equipment, and a research library collection with over 4,000 volumes. The organization regularly acquires new books for the library in both the US and Mongolia. Grants supporting these activities in the current year were received at the beginning of fiscal year 2012 (October 2011).

4b (Code:) (Expenses \$ 94,011 including grants of \$ 100,000) (Revenue \$ -0-)

Fellowships/Conferences/Lectures: the organization supported four fellowship programs with grant funds received at the beginning of fiscal year 2012 (October 2011) and in fiscal year 2011 from the US State Department, Henry Luce Foundation, Shelly Rubin Foundation. The programs provided \$89,762 in fellowship awards to 14 US students and faculty, 1 Faculty from Denmark, and 5 scholars from Mongolia. Fellowships support field research and language acquisition for students and faculty. In addition, the organization held conferences and public lectures in Mongolia in support of the fellowship programs and as part of the organization's public outreach goals. These activities were organized by staff in Mongolia.

Center Operations in Mongolia: The Resident Director in Mongolia is responsible for maintaining financial records for the office in Mongolia. Each month she submits a copy of the accounting books and scans of receipts to the US Director who reviews the records concurrently with his preparation of the US books. Both are then submitted to the Executive Director for review. The office in Mongolia generally receives transfers to cover operating costs, and expenses are booked in the month they accrued in both the US and Mongolia financial records. The Mongolia office may request an advance of funds to cover expenses, and later reimbursements are adjusted accordingly by subtracting out advance amounts. The Mongolia office maintains four accounts at a Mongolian banking institution, 2 in US\$ and 2 in Mongolian tugriks. The office also maintains a petty cash account in dollars and tugriks that normally should not exceed \$200 in balance, although exceptions to this rule do occur when alternative methods of receiving or distributing payments are not available. All transactions are recorded with receipts and monthly statements from the banking institution. Each year the Executive Director or US Director visits the Mongolia office to review operations and verify records are being handled and stored properly.

Fellowship selection and oversight: Each fellow must submit an application to a competitive process which includes review of personal statements and academic or professional achievement by a selection committee. After the selection committee makes their recommendations for awards, awardees are notified in writing of their selection. Part VI Line 7a: Members join the organization by paying annual dues. Membership comprises students and individuals. Every three years elections are held for five "At-Large" members of the board of directors for three year terms. Active members, as defined as having paid the annual dues for the current year, are eligible to vote in these elections. Members are also eligible to nominate candidates. As of writing this, the ACMS has over 400 active members. Membership is defined in the corporate by-laws to begin September 1 and end August 30 of each year for purposes of determining a member's active or non-active status.

Institutional members join the organization by paying annual dues. Institutional members may select a representative on the board of directors. Institutional representatives along with "At-Large" directors may nominate and vote for officers and members of the Executive committee. They may also, as outlined in the corporate by-laws appoint members to committees. As of writing this, the ACMS has 43 institutional members.

Part VI Line 19.: The corporate by-laws of the organization are available on the organization website, along with a list of institutional members and members of the board of directors (see www.mongoliacenter.org). The organization also maintains a policy manual to guide operations. This manual is available upon request but is not normally shared with the public. It is, however, available to all officers, directors, and employees. Within this policy manual are the conflict of interest policy, as well as other rules and regulations. At each annual meeting of members, which is open to the public, a general statement of the organization's finances are presented by the Treasurer or other officer present at the meeting. Other financial records are available upon request but are not normally shared with the public.

Part XI Line 2c: The Executive Committee, which comprises the officers of the board, reviews the financial statements quarterly. The Executive Director submits an annual financial statement to the board for review. This statement is in addition to the 990 form, because the annual meeting is generally held in spring before filing the 990. The organization is not required to submit to an annual A-133 audit; however, it does receive a review of its books and financial statements by an independent auditing firm. The review reports are provided to the President, Treasurer, and Executive Director in original hardcopy form when received, and copies are available on request.
