Staff and parents are educated using evidence based information on social-emotional development from Center on the Social and Emotional Foundations for Early Learning (CSEFEL) and Technical Assistance Center on Social Emotional Intervention for Young Children (TACSEI), appropriate behavioral interventions, positive behavior supports, strength-based practices, inclusion, best practices and the benefits of high-quality childcare programs. *In 2012, FIRST served 116 children in 31 different centers with 89% of staff trained rating trainings as helpful.*
 - **The Incredible Years BASIC Parenting Class** with funding from Smart Start and partnering with the local YWCA for location and childcare, is open to families who find their child's behavior challenging. This research based program having been offered for four years, has been proven effective as an empowerment process for parents and has improved outcomes for their children. *In 2012, 14 parents completed 11 of 14 sessions which impacted 31 children age 3 to 5 years.*
 - **The P.L.A.Y. Project**, a research based program, trains parents to provide the American Association of Pediatrics recommendation of 25 hours per week of intensive interventions to their young child with autism. FIRST has secured scholarship funds enabling more families to benefit from the yearlong training program. *In 2012, all parents improved that their forming relationship and two way communication skills and all children improved in their behavioral organization skills. Since starting the program in 2009, 34 families have participated in the parent training program.*
- Focus on School Readiness** funding by Janirve Legacy Fund to work closely with 5 childcare centers in Asheville to improve the Kindergarten readiness of their staff and children using evidence based models. *Program started in July of 2012, 5 childcare centers have signed up and the first assessment of children is complete.*
- **Family Support Funds** program provides assistance with basic needs, home furnishings/modifications, respite, adaptive equipment and even repairs to vehicles. The types of assistance includes connecting of an individual to vocational, social, and educational opportunities in the community, whatever it takes for people to live and participate fully in their community. With limited funding, FIRST works with the families who meet eligibility requirements to leverage the project dollars creating parent/consumer leadership skills and community support for persons with disabilities. *In 2012 ending in June, we used \$4036 FIF funds to leverage \$10,240 worth of products and services. \$916 of FIRST funds were used for a total of \$4953 to get \$10,240 for 18 families.*
 - **Summer programming**, partnering with Asheville Parks, Recreation and Cultural Arts, Therapeutic Division to offered to children and youth with all disabilities. The programs are staffed by a therapeutic recreation specialist includes fun activities but also self-advocacy skills training, literacy and

public speaking. *In 2012, 28 actors performed for over 220 people on the stage of Dr. Wesley Grant Southside Center.*

- **YouFindServices.org** is an online searchable “phonebook” for parents and professionals, to locate services for children with special healthcare needs. FIRST hosts this site and will maintain it for up-to-date and accurate information. *After two years in the making and with the input from close to 100 parents and professionals the searchable website for families of children with special health care needs went live on April 11, 2012. Close to 100 providers have signed up and over 200 users have accessed the website.*
