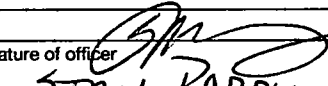

School music, anti-bullying, exercise and other programs were supported along with camp scholarships and nutrition initiatives.

Scholarships were awarded to college bound high school seniors and continuing college students. While Foundation funds support these efforts, recipients are chosen through criteria developed by those related programs making the determination and selecting the student recipient. 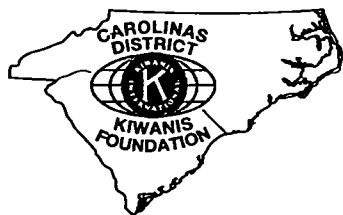
