School Based services are offered to children and adolescents creating a safe and supportive environment which is the key to their emotional development and well-being. The Organization provides prevention programs that address substance abuse, bullying, anger management, and gang prevention. The Organization provides intervention programs for at-risk students who need counseling, mentoring, and tutoring to support them both academically and emotionally. A full range of therapeutic services are available from licensed clinical staff, including counseling, art & play therapy, support groups, and school based programs to help children and adolescents succeed in life.

4b (Code:) (Expenses \$ 1,231,328. including grants of \$ 173,591.) (Revenue \$ 54,436.)

Counseling services are offered to children, adults, families, and seniors. The Organization provides a full range of counseling addressing issues such as depression, parenting, marital conflict, substance abuse, bereavement, stress management, gender identity, divorce and remarriage, and domestic abuse.
