The Sharing Center provided assistance to 13,532 families in fiscal year 2011-2012. 9,260 families received food; 6,651 families received clothing; 4,554 families received medical assistance; 498 families received shelter assistance; 216 families received utility assistance; 134 families received transportation assistance; and 1,441 shoe gift cards were handed out at all events.

Thrift store - During fiscal year 2011-2012, the thrift store sales totaled \$503,085, which proceeds were used to further the mission of the Sharing Center.
