The St Johns Cultural Council ("SJCC") signed an agreement with St Johns County to administer the portion of the County's tourist development tax revenue designated for support of arts, culture, and heritage programming. Accomplishments included 1) revising the county's prior grant program to better comply with the Florida Statutes, 2) hosting grants and technical assistance workshops, and 3) developing a five year strategic plan for expenditures of the tourist development tax funds. Grants were reviewed and awarded for the period October 1, 2012 to September 30, 2013. Actual payments of the grants are administered by St. Johns County.

4b (Code:) (Expenses \$ 8,330 including grants of \$ 8,330) (Revenue \$ 8,410.)

The SJCC provides micro-grants and provides funding for contractual services to local arts organizations and individuals. Funding for these programs comes from the sale of "State of the Arts" license plates, ROWITA grants (recognizing outstanding women in the arts) and individuals. During the 2011-2012 fiscal year, six organizations and 13 individuals received grants and 7 individuals received payment for contractual services. All program funding promotes art education.
