The U.S. Space & Rocket Center Foundation is a 501(c)(3) organization, which supports the educational programs of the U.S. Space & Rocket Center and SPACE CAMP, through grants, fundraising, scholarships, and corporate sponsorships.

Through the fundraising efforts of the Foundation, donations are made and allocated to the U.S. Space & Rocket Center for scholarships to attend Space Camp and other educational museum programs. Space Camp and affiliated programs provide hands on learning of Science, Technology, Engineering, and Math (STEM) in an immersive setting using Space Exploration as the theme and backdrop. This same technique is applied in our educator programs and not only teaches our educators but provides learning tools and inspiration that they can take back to the classroom. In FY12 318 teachers received scholarships to attend Space Academy for Educators, and 583 students were scholarship recipients. Based on restrictions from donors, travel, expenses are often covered by the scholarship funds in addition to lodging and meals throughout the program. The Foundation granted funds to the U.S. Space & Rocket Center to fund additional museum exhibitions. During the fiscal year the museum hosted three traveling exhibits. The first was a Field Museum exhibit called Mammoths and Mastodons. Following that, the museum hosted an ASTC exhibit titled Black Holes: Space Warps and Time Twists. The third exhibit hosted was an Evergreen production called MathAlive! This highly interactive exhibit focused on everyday entertainment and disciplines and taught the math involved in the subjects. They included areas such as music, dance, bridge designing, snow boarding, fashion design and space exploration to name just a few. This exhibit was extremely popular and attracted teachers and their students from around the Southeast. In addition to the traveling exhibit we added two permanent exhibits. These were high-fidelity dioramas of the moon scape and mars surface with space stations and other miniature depictions of life on other planets. Other exhibit grants are funding projects that were still in development at the close of the fiscal year.

4c (Code:) (Expenses \$ 0 including grants of \$ 157,950) (Revenue \$ 0)
The Foundation solicited funds from corporate and private donors to sponsor several major events throughout the year. The first event took place in February December, a celebration of the 40th year since the Apollo 17 mission, the final Apollo mission to go to the moon. In February we celebrated what would have been Dr. Wernher von Braun's 100th birthday with a black tie dinner under the Saturn V Rocket. We also held several smaller summer events. In total the sponsorships supported more than 2,000 people for the various different milestone events. The events were all hosted by the U.S. Space & Rocket Center but underwritten by funds raised by the Foundation. These events support the missions of the Foundation and keep the community at large engaged and up to date on what is current in the Museum.
