The Mississippi Nurses Foundation provides scholarships, stipends and grants to nursing students and registered nurses throughout the state of Mississippi who are pursuing degrees in nursing The Mississippi Nurses Foundation is pleased to offer grants for scholarly activities by nurses to address health care problems in Mississippi The two areas of interest are projects addressing major health problems in MS (e g , infant mortality, obesity, teenage pregnancies, et al) and projects addressing evidenced-based or outcomes-based nursing in MS (ie , clinical practice, education, or administration) Depending on the application, funds may be used for implementation and/or dissemination of study outcomes The Mississippi Nurses Foundation was awarded \$25,000 from Health Management Associates (HMA)-Mississippi Division to sponsor a statewide High Five hand washing program for the 2010-11 school year Health Management Associates \$25,000 sponsorship allowed the MS Nurses Foundation to provide hand washing supplies and materials to elementary schools throughout the state The goals of the High Five Hand Washing Program are as follows 1 Teach hand washing to children in order for them to be healthier and develop a lifelong health habit 2 Reduce the number of absentees for the school, which increases funding for the school 3 Collect data that will show a significant reduction of absentees related to communicable illness The Mississippi Nurses Association and the Mississippi Nurses Foundation hosted its seventh annual Nightingale Awards Black-tie gala for nearly 700 nurses and friends of nursing on March 5, 2012 at the Marriot Hotel in Jackson, MS This black-tie event highlighted the achievements of outstanding nurses in our state who contributes significantly to health care of our citizens and to those who support the work of nursing in a vital way The organization received 103 nominations for awards in 17 categories, with two inductions into the Mississippi Nurses Association Hall of Fame The Mississippi State Department of Health Office of Rural Health awarded a \$10,000 grant to the Mississippi Nurses Foundation The project, "Rural Health Nurse Recruitment" focused on developing activities to increase the number of health care professionals practicing in rural communities The program included presentations to inform nursing students, hospital nursing staff and high school students about nursing career ladders and education/training incentive programs (loan repayment and scholarships) with a focus on encouraging careers in rural areas The project was coordinated by a nurse practitioner or a graduate level nursing student The Mississippi State Department of Health Office of Tobacco Control awarded a grant totaling \$99,683 to the Mississippi Nurses Foundation to collaborate with Schools of Nursing to survey nursing students on their preception and general belief of tobacco use and tobacco cessation and the need for a comprehensive statewide smoke-free law The Foundation developed activities to educate nursing students enrolled in Mississippi Schools of Nursing about tobacco prevention and control to ensure they are empowered to educate and influence their future patients
