The Friends of Scotchman Peaks Wilderness believes that the 88,000-acre Scotchman Peaks IRA (Inventoried Roadless Area) deserves permanent protection through wilderness designation by congress. The Scotchmans are a biologically rich and diverse area with unique plant communities and critical habitat for threatened, endangered and sensitive fauna such as the Grizzlie Bear, Canada Lynx, Bull Trout, Mountain Goat and Wolverine. Its steep ridges and deep valleys offer outstanding opportunities for recreation and solitude. Our goal is to create community support for wilderness designation through education and community outreach.

Our outreach and education efforts have resulted in growing our support list to over 4,200 individuals, including supporters from 38 states. Over 80% of our supporters are from the region of eastern Washington through northwestern Montana.

Our most effective form of communication remains our newsletter, put out 6 times a year and distributed to over 85 locations throughout the region from Spokane to Libby to Missoula and many points in between!

We have seen an increase in visitors to our website, providing information on the value of preserving the wilderness characteristics of the Scotchmans. Our website has also been an effective method of providing information on events and activities. Our facebook page continues to grow in use and provides an interactive forum to bring together our supporters and volunteers and engage them more effectively.

Through hikes and volunteer stewardship activities (trail maintenance, wildlife studies and naturalist classes) we continued to bring a large number of people

into the Scotchmans to in all seasons. In the winter and summer of 2012, over 250 individuals joined us as volunteers or as part of one of our organized hikes into the area. Beyond engaging volunteers, our stewardship activities have benefits for resource protection. In the summer of 2012 we hired a part time coordinator to manage our summer trails programs. Our hiking map, distribute free of charge, has assisted both hikers as well as those who simply want more information about the area.

In addition to trail maintenance activities on three ranger districts in two national forests, in the winter of 2011-2012 we partnered with Idaho Fish and Game to provide volunteer assistance in setting and checking stations as part of a rare forest carnivore wildlife study.

We have used our both the trail maintenance and wildlife studies to engage students from many local schools and regional schools from the middle school, to high school and college level. We continued our Scholarship Program for high school seniors and an Essay contest in Sanders County for the Middle and High Schools.

We hosted or participate in many community events to engage the general public and our supporters alike including our annual "State of the Scotchmans" in May where we update supporters and the community on our progress and activities.
