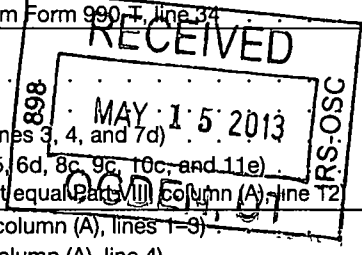

Under the by-laws of the Abilene Chamber of Commerce, the Executive Committee acts for and on behalf of the Board of Directors when the Board is not in session, but is accountable to the Board for its actions. The Executive Committee is comprised of the officers of the organization, the chairs of all affiliates and standing committees and three members at large from the Board. Generally the Executive Committee meets eight times per year and the Board meets four times per year.

If no petition is filed within the prescribed time period, the nominations shall be closed and the nominated slate of directors shall be declared elected by the Board of Directors. If a valid petition is filed, the Board of Directors will vote on the nominees by written ballot with the candidates receiving the greatest number of votes being elected.

Special meetings of the membership may be called by the Chair at any time or upon petition in writing by any 10% of the existing members in good standing. Notice of special meetings of the membership shall be sent to each member at least 5 days prior to such meetings.

The Abilene Industrial Foundation (AIF) is designed to promote the growth, development and diversification of the economy in and around Abilene, Texas by attracting new industries, retaining and expanding existing industries and supporting the federal, state and military agencies presently located in Abilene, Texas. AIF conducts an annual pledge drive to raise funds from private sector businesses to be used for these purposes.

The AIF and the Abilene Chamber of Commerce have a joint contract with the Development Corporation of Abilene for services and reimbursement for certain expenses incurred for the purpose of promoting and marketing Abilene and the vicinity, including pursuit of additional missions at Dyess Air Force Base. The Program Services Accomplishments on this Form 990 include expenses of \$660,149 and revenue of \$714,404 related to the joint contract. Revenue in this Form 990 also includes \$44,800 from the AIF in
