The organization provides counseling to pregnant women regarding prenatal and parenting issues to assist mothers in making the best decisions for their children. The organization assists birth mothers with medical costs, transportation to and from doctor appointments, food, toiletries, and other living expenses. For birth mothers who choose adoption, the organization places the adoptive children in safe, stable and loving homes. The organization receives adoption fees from adoptive parents, including application fees, home study fees and placement fees. For birth mothers who choose to keep their babies, the organization provides them with counseling and links them to other community agencies that provide assistance. For the tax year ending September 30, 2012, the organization received calls from forty-two pregnant women and worked on a continuing basis with twenty-six of those women. Ten babies were placed for adoption during this period.

The organization's staff provides educational programs to promote adoption awareness and to educate pregnant women about their options.
