Health Advocacy: These projects include trainings in the communities of Fresno, Madera, and Santa Maria, California; trainings consisted of knowing the steps in which to make a change in the area, these are done so that people who wanted to make a change in how the clinics, hospitals, or other health related entities operate will have their issues addressed in their particular community. In the building healthy communities program, the focus is on advocating for the way the city will be developed to include health related items into plans. Also within this category are the programs in which participants advocate for the health reform and some of the implementation of this reform.

4b (Code:) (Expenses \$ **197,363** including grants of \$) (Revenue \$)
Education: Educate parents of children ages 0-5 in the county of Monterey and Fresno, California on how to help their children at this age so that they can become more involved once they reach school age. Workshops are done to show parents what it is that they need to know in order to develop the skills of their children. This project is also focused on the parent in which they identify an issue of which is of great importance for the child at this age and how they can better the communication with that agency to achieve greater resources from them. Another part of Education is the scholarship program that has provided scholarships to nine students in order for them to continue their education after completing high school.

4c (Code:) (Expenses \$ **122,461** including grants of \$) (Revenue \$)
Health: Health insurance outreach and enrollment in the communities of Fresno and Madera, California. A cultural component allows CBDIO to provide cooking classes to the indigenous community in order for them to eat healthier while using traditional foods. Organic gardens have been developed in the community of Hollister, California, to give the community an opportunity to grow organic food and eat healthier. Health programs also includes outreach on the dangers of some chemicals to the general public but mainly to the farm workers. This specific program is taking place in Fresno and Santa Maria, California.
