The Ministry operates a Children's Home for dependent children who have experienced abuse and neglect. Two large homes are designated for extended care, providing a home for children needing a place to live for up to two years or longer until they can be restored to their natural family. Another home, House of Hope, provides short term care to kids in crisis. Certified counselors work with the children in a play therapy room located on the property.

KNMI, Vertical Radio, located at 88.9 on the FM dial, was the first Christian radio station in the Four Corners region. Since 1980, KNMI has provided Christian teaching, public affairs programs and uplifting music to the varied cultures in the Four Corners. In recent years, the station has also broadcast high school sports. KNMI is broadcast live on the World Wide Web at VerticalRadio.org. The station is an educational non-commercial broadcast facility funded by the community.

The Counseling Center provides for the counseling needs of the children living at Four Corners Home for Children and also provides support for the house parents. In addition, the Counseling Center provides hope and encouragement to families in the Four Corners region (including Navajo Nation) who are struggling with marital and relationship issues. Services are provided on a sliding scale basis.

Should any penalties and interest be incurred, they would be recognized as administrative expenses.

Based on the results of management's evaluation, these requirements did not have a material effect on the Ministry's financial statements. Consequently, no liability or expense is recognized in the accompanying statements for uncertain income tax positions.

Because many of the children come from traumatic backgrounds, the smaller setting has been a blessing to these fragile youngsters. The curriculum is provided by the public schools. They also provide a portion of the teachers' salaries. The students have excelled in this on-site school, with some receiving high test scores. Total expenditures for this program were \$37,718.

Navajo Outreach - Navajo missionaries conduct marriage and family seminars in the Navajo Nation. In the summer, several VBS Programs are conducted in the Navajo Nation. During the Christmas season, needy families receive assistance through personal visits in their homes. Total expenditures for this program were \$19,984.
