THE PUEBLO ART, CULTURE AND HISTORY TAUGHT COMPLEMENTS THE GUIDED TOURS OF OUR PERMANENT AND CHANGING EXHIBITS, AS WELL AS THE IPCC MURALS. STUDENTS EXPERIENCE A FIRSTHAND LOOK AT THE 19 PUEBLOS OF NEW MEXICO GUIDED BY PUEBLO TEACHING ARTISTS. THE EXPERIENCE CULMINATES IN A HANDS-ON ART PROJECT THAT RELATES TO PUEBLO LIFE. IN 2012, IPCC HOSTED TWO PUEBLO HOUSE SUMMER DAY CAMPS FOR PUEBLO, NATIVE AMERICAN AND NON-NATIVE YOUTH AS WELL. THE DAY CAMP IS AN IMMERSION-BASED PROGRAM EXPLORING PUEBLO INDIAN CULTURE, HISTORY, ART, MUSIC, AGRICULTURE AND FOOD. IPCC OFFERS GUIDED AND SELF-GUIDED TOURS

THE INDIAN PUEBLO CULTURAL CENTER (IPCC) OFFERS YEAR-ROUND TRADITIONAL NATIVE AMERICAN DANCE PERFORMANCES ACCOMPANIED BY INTERPRETIVE PROGRAMMING. THE DANCE GROUPS REPRESENT A PORTION OF THE 19 PUEBLOS OF NEW MEXICO AND SEVERAL GROUPS FROM OTHER SOUTHWESTERN TRIBES. THERE ARE TWO PERIODS DURING EACH YEAR WHERE WE INCREASE THE NUMBER OF DANCES AT THE CENTER: 1) AMERICAN INDIAN WEEK-PUEBLO DAYS CELEBRATION, LAST FULL WEEK IN APRIL; AND BALLOON FIESTA WEEK, 10 DAYS AT THE BEGINNING OF OCTOBER. EACH YEAR, THE IPCC PRESENTS OUR PUEBLO ARTIST WORKSHOP SERIES (PAWS). THESE WORKSHOPS PROVIDE NATIVE AND NON-NATIVE ADULTS AND YOUTH, TO BECOME STUDENTS IN OUR CLASSROOM, AND LEARN TRADITIONAL ART FORM TECHNIQUE AND CREATIONS FROM ESTABLISHED PUEBLO ARTISTS.

THE INDIAN PUEBLO CULTURAL CENTER (IPCC) PRESENTS EXHIBITIONS BASED ON PUEBLO INDIAN CULTURE, HISTORY, ART AND LIFEWAY. A STRONG FOUNDATION AND EMPHASIS IS PLACED UPON PUEBLO CORE VALUES AS THE SOURCE TO GUIDE EXHIBITION AND PROGRAMMATIC DEVELOPMENT.
