 Bus Ministry/Adopt a Block/Food & Clothing to the Needy of the Community-The organization distributes food & clothing at no cost to those within the community who need help and assistance. The organization is feeding approximately 4,500 meals per week during community outreaches through Food Bags and Hot Meals. The organization is also providing approximately 2,000 pieces of clothing weekly to those in need

4b (Code:) (Expenses \$ 1,091,439 including grants of \$ 116,614) (Revenue \$ 29,031)
 Feeding, Housing, Clothing & Training Disciples-The organization provides short and long-term, no/low cost housing for individuals eighteen years of age or older as well as training (life skills, financial, relational and spiritual) and clothing to those who need help, assistance and rehabilitation. City Help, Inc. of Phoenix houses approximately 295 individuals per week. Approximately 6,000 meals are given out to residents on a weekly basis.

4c (Code:) (Expenses \$ 207,284 including grants of \$ 58,328) (Revenue \$ 0)
 Rescue Project-The Rescue Project provides a stable, safe environment for young girls and women (typically between the ages of 14 and 26) who have been caught up in the human trafficking pipeline and wish to get out. During this reporting period the age ranged from 16 to 26. However long term housing is not an option for minors who have no legal guardianship established. This program is a therapeutic transitional living program geared toward the spiritual, emotional and physical healing of these young women. This free program provides housing, food, clothing, medical care, legal assistance, counseling and training to assist in the transition to a normal, productive life. During this reporting period, 45 women (some of which were pregnant) participated in this program with an average length of stay of 38 days.

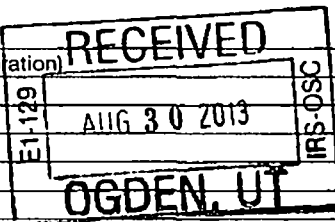
