EDUCATION: Utah Domestic Violence Council (UDVC) has provided training to over 900 community members concerning the dynamics of domestic violence, trauma informed advocacy, and issues concerning safety and the protection of children. UDVC also hosts a web based training that was accessed by 228 individuals. UDVC is recognized as the leading expert in the state of Utah concerning issues of family violence. UDVC staff have received specialized training to assist in meeting the complex safety needs in a variety of populations with unique service needs. Utah is a primary refugee resettlement state, as well as having nine different tribes of first nations peoples. UDVC helps educate service providers throughout the state about the safety concerns and needs of these diverse communities. UDVC convenes and facilitates monthly meetings with State and local

OUTREACH: UDVC provides outreach to over 33 local Domestic Violence Coalitions to assist in community prevention and education initiatives. UDVC's website provides information concerning prevention, safety planning, local resources, and links to local, state, and national resources. UDVC participates in community events and has partnered with many other stakeholders to provide information about services to over 2600 people. UDVC staff work in all rural communities, and provide outreach to underserved communities including refugee communities, polygamist communities, native tribes, the military, the LGBTQ community, and various schools and organizations.

4c (Code:) (Expenses \$ 139,151. including grants of \$ 0.) (Revenue \$ 0.)

LINKLINE: the UDVC Linkline program provides a 24/7 statewide domestic violence crisis line which includes interpreter services, responding to 2170 calls and providing service to over 4700 people. This service provides immediate safety planning, and resource referral throughout Utah. This is a completely confidential service which is often the trusted point of access to folks who experience barriers to services in Utah. Utah has a growing population of LGBT who often face cultural barriers to services in Utah. In addition, there are families who have other religious and or cultural differences from mainstream Utah who recognize the UDVC Linkline as a safe and effective resource. Utah is a primary refugee resettlement area and the UDVC provides much needed interpreter services to accommodate the many languages spoken in the state.
