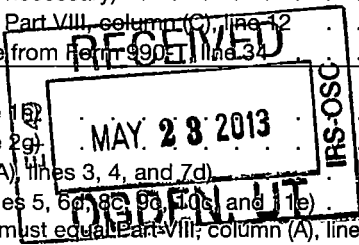

## PAIR sample program outcome

Since 2010 DRW staff have participated in a cross-system work group convened by the Secretary of the Department of Social and Health Services to improve the adult abuse response system. The work group made eight recommendations for immediate consideration and a number of recommendations for future improvements. In FY 2012, DRW continued work to ensure implementation of several of these recommendations. Progress so far includes: review and implementation of the statement of abuse victim rights form and process for distributing the rights statement to victims and their legal representatives.

DRW successfully advocated for inclusion of referrals to appropriate victim advocates; implementation of increased Adult Family Home licensing fee structure which funds increased licensing, inspection and abuse investigations in Adult Family Homes. DRW advocated for these increased fees and increased civil penalties which partially fund the abuse response system; design and roll out of a new data base to collect information about abuse and neglect of vulnerable adults. DRW advocated for a data system to improve the department's ability to investigate and track abuse and neglect of elders and adults with disabilities across systems and to hold perpetrators accountable; Adult Family Home quality assurance panel convened and drafted a report to the legislature. DRW is a member of the panel which will release its report in December 2012; and increased awareness by people with disabilities, the services system and law enforcement of the importance of an effective abuse response system.

Through the work group many advocate groups now have improvements of the abuse/neglect response system as part of their legislative and education agendas. The training sub-committee of the Abuse Neglect work group piloted a project to increase appropriate 911 calls by facility inspectors. The continued analysis of the abuse response system by the work group identified gaps in the system and possible solutions to improve the state system and the response by law enforcement and the community. At this point, the ARS workgroup is continuing and thus, we are closing the project. All future work on and outcomes from the workgroup will be recorded in a new systems advocacy project called ARS collaboration.

ACTUAL OUTCOME: The rights of approximately 110,000 were expanded from 4+ positive changes in policy, law, regulation, or practice as a result of the pursuit by DRW of one or more of the desired outcomes assigned to this goal/priority.

ACTUAL OUTCOME: \$ 6 million+ federal and state, were secured to fund supports or services or address a disability rights related issue as a result of the pursuit by DRW of one or more of the desired outcomes assigned to this goal/priority. This funds the new critical incident tracking system. ACTUAL OUTCOME: 1 initiative resulted in the education and training of 300 people on issues related to one or more of the desired outcomes, goals and/or priorities.

ACTUAL OUTCOME: 2 initiatives with partners resulted in a collaborative effort in pursuit of common goals related to one or more of the desired outcomes, goals and/or priorities benefiting 110,000 people.

**Additional program outcomes**

PAIMI - As a result of two DRW's investigations, we learned that a facility providing care to children with mental health issues was failing to follow established law and policy regarding the use of seclusion and restraint with youth. DRW met with the facility staff and explained that based on DRW's review of four patients' records, there were significant concerns with their use of seclusion and restraint. The facility stated that it would look into DRW's concerns. We sent a letter demanding that the facility: Provide written assurances that it would modify its seclusion and restraint policy; Begin to track the data regarding its use of seclusion; Operate pursuant to established clinical best practices; No longer use property destruction or the failure to follow direction as a basis for seclusion; and to Continue to work with DRW to address these concerns.

The facility provided DRW with a thirteen step corrective plan including creation of a design team to resolve all identified issues, revision of policies to limit seclusion and restraint only when "all other less restrictive alternative interventions have not been successful to maintain the safety of both residents and staff", improved reporting to DRW, and policy revisions and training of staff to shift its treatment philosophy to a more positive therapeutic approach.

DRW continued to meet with the administration. During these times, DRW also conducted monitoring of the facility and met with youth to check in about how things were going. During the one monitoring visit, we met with youth and learned that the seclusion and restraint practices had drastically improved at the facility.

While youth once reported having a seclusion and restraint event nearly every day, the youth informed DRW conditions regarding seclusion and restraint had drastically improved and the staff was engaging with them more positively and that there were more activities for them to do including off site equine therapy.

Finally, DRW met the facility and made some final suggestions to policies but determined that the facility had implemented its thirteen step corrective plan addressing DRW's concerns. **Actual Outcomes:**

13+ youth with mental health issues benefited from 10+ positive changes in practice

13+ youth with mental health issues benefited from changes in their environment

13+ youth with disabilities had their rights enforced and/ or restored

PADD - A client's Medicaid Personal Care hours were reduced by 57% in accordance with WACs 355-106-0213 and 388-106-0130. Her objective is to have these hours reinstated and for these rules to be declared invalid.

DRW provided individual representation to client at administrative hearing to challenge the 57% reduction of Medicaid Personal Care services based on WACs 388-106-0213 and 388-106-0130. DRW represented client in petition for review of the administrative decision and to invalidate the regulations requiring the reduction. Original representation agreement to investigate Sam's reduction of Medicaid personal care hours and provide representation at the Administration Law Hearing.

DRW represented client on appeal. In 2011, the Washington Supreme Court issued opinion in favor of client, declaring 388-106-0130 and 0213 invalid on the basis of federal Medicaid comparability requirements. In 2012 DRW successfully represented the same client opposing a DSHS motion for reconsideration.

1 person with disabilities benefited from access to administrative or judicial processes being secured. The Department repealed the rule but then replaced it with another emergency rule that is still somewhat problematic. As a result, about 19.4% of the 3,023 received increased hours. Additionally, individuals are more aware of their rights and now have a right to go to fair hearings because the irrebuttable presumption has been removed.
