CASCADE ANIMAL PROTECTION SOCIETY ADOPTED OUT 114 CATS AND 31 DOGS. LOW INCOME AND SENIOR CITIZENS WERE ISSUED 126 CERTIFICATES THAT ENABLED THEM TO SPAY AND NEUTER THEIR COMPANION CATS AND DOGS. EMERGENCY VETERINARY TREATMENT WAS PROVIDED TO 128 ANIMALS WHOSE OWNERS COULD NOT AFFORD TO PAY FOR TREATMENT. THOSE ANIMALS WOULD HAVE GONE UNTREATED WITHOUT OUR ASSISTANCE.
