The Fund for Art & Dialogue is a non-profit organization that gives visual artists unrestricted financial awards and a national network of support Artadia currently operates in five cities Atlanta, Boston, Chicago, Houston and San Francisco and has its base in New York We rotate and run award cycles in these five cities and offer all awardees a chance to participate in our artist-in-residence program at ISCP in Brooklyn, NY, our publications, interactive website and exhibitions and talks around the country In October 2011, we ran an award cycle in Atlanta, Georgia, where we gifted 7 artists with unrestricted artist awards Our residency program occurred in fall and winter 2011 and 4 artists enjoyed 3 month studio residencies at ISCP In December of 2011, Lila Kanner, the executive director of Artadia left her position and the office in Chelsea closed in spring 2012 In July, 2012, Artadia relocated to DUMBO Brooklyn, where they inaugurated the new Artadia exhibition space, that features 6 exhibitions a year In July 2012, Carolyn Ramo was appointed Executive Director In September 2012, Artadia ran an award cycle in Chicago, Illinois where it awarded 7 artists with grants and exhibited work by all the finalists at the inaugural EXPO Chicago fair At the end of FY12, the application opened for Houston area artists, with an award cycle completed in FY13
