Youth Art Program - this program provides year-round arts programming, in the form of music, dance, visual arts, media, culinary arts, organic gardening, and field trips, for at-risk youth, ages 5-19, that live in low-income neighborhoods and public housing communities throughout Seattle and King County, WA. Programming is held during both out-of-school time hours as well as in-school time 50 weeks per year. In fiscal year 2012, 1,414 youth were served with 847 classes totaling 1,694 program hours and 15,246 participant hours at 17 sites.

4b (Code ) (Expenses \$ 184,247. including grants of \$ ) (Revenue \$ 6,200.)

Urban Forest Restoration Project - this is a long-term, on-going habitat restoration, stewardship, and education project in the West Duwamish Greenbelt (WDG), which is the largest remaining contiguous forest in Seattle. The WDG is an important ecological resource for the entire King County region and is home to wide range of bird species and wildlife and provide recreational opportunities for the region's residents. In fiscal year 2012, 2,889 volunteers were engaged in 148 volunteer work parties and 8,932 hours of service, and 1,428 hours of education. During this time, 920 native trees and 3,209 native shrubs and understory were planted, tons of invasive vegetation was removed from 751,480 square feet of forest, and over 60 acres were maintained and stewarded.
