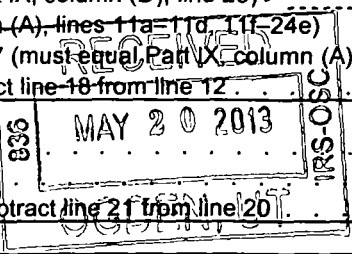

4. Describe the exempt purpose achievements for each of the organization's three largest program services by expenses.

4a) (Expenses **\$331,375** including grants of \$331,375) (Revenue \$331,375)

These expenses were associated with a project funded by a Math and Science Partnership grant from the Oregon Department of Education to further expand the Mathematics Studio Program in Oregon as context for *establishing a proven, school-based mechanism* for institutionalizing a culture of mathematics professional learning that is guided by a clear research-based vision of how students learn mathematics. Through this funding, TDG is charged with creating three flagship Oregon sites- one elementary, one middle, and one high school in two Oregon districts- that will support dissemination of the Math Studio Program to other Oregon and national districts. During the fiscal year 2011-2012 work on this project included mathematical professional development in Bend and Medford School Districts. Over 100 teachers participate each year in 102- 148 hours of professional development, and many will participate during multiple years, directly impacting between 9,000- 11,000 K-12 students.

4b) (Expenses **\$204,886** including grants of \$204,886) (Revenue \$204,886)

These expenses were associated with the Mathematics Studio Fellowship Program - A Model for Mentoring New and Master Teachers, funded by the National Science Foundation (NSF) through NSF grant #0934953. This project focuses on the development of Master Teaching Fellows (MTF), classroom teachers who receive school-based coaching by Teachers Development Group (TDG) consultants (K-12 master teachers) in high needs schools that have served as pilot sites for TDG's *Mathematics Studio* model. Prior to 2011-2012, this project was situated in two Oregon school districts and three Washington State districts, where participating high-needs schools have shown dramatic and continuous gains in mathematics achievement, and the program has expanded to include a broad base of teachers, teacher leaders, and school and district administrators. During fiscal year 2011-2012 project expenses were related to continued and expanded support in those districts as well as the launching of new partnerships involving MTFs in Medford School District (OR), Hamilton County Department of Education (TN), and Richmond County Board of Education (GA).

4c) (Expenses **\$136,491**) (Revenue \$152,040)

These expenses were associated with the 2012 Leadership Seminar on Mathematics Professional Development. This seminar is an annual event sponsored by Teachers Development Group and is a major activity to disseminate the TDG mission. The seminar brings mathematics educators who lead the field in innovation and research together with school district teams of administrators and teacher leaders seeking guidance and support for designing and implementing the highest quality, research-based professional development. It also provides context for the Master Teaching Fellows described above to meet, learn from, and interact with exemplary professional development leaders from across the United States. Finally, it supports the knowledge and leadership development of the TDG staff members who lead work on behalf of TDG in school districts across the nation.
