The Asante Foundation's primary exempt purpose is to raise monies and in-kind donations to further the exempt purpose of Asante, a 501(c)(3) hospital and healthcare system which services the healthcare need of the citizens of southern Oregon and northern California.

Form 990, Part III, Line 4a - Program Service Accomplishments

During the tax year, the Asante Foundation's largest program service accomplishment was the granting of \$709,670 to benefit various departments and capital projects at Rogue Regional Medical Center (RRMC), a 378 licensed bed hospital located in Medford, Oregon.

Of the capital projects, over \$219,000 was donated this year to complete the Neonatal Intensive Care Unit (NICU) remodel and expansion. This capital project almost doubles the overall size of the NICU and adds an additional 10 bassinets and giraffe beds. All new high efficiency lighting and patient monitoring systems are included in the project. Now completed, the overall increase in patient volume is expected to be modest, but the major focus of the new expansion is to increase the efficiency and quality of care to the babies and their families.

Another major capital project includes the completion of the fundraising campaign to purchase a new \$5 million state-of-the-art radiation tomotherapy machine. Nearly \$31,000 was raised this year to complete the project. Other capital projects include an \$85,000 donation toward the a new pediatric assessment clinic.

In addition to donations for capital projects, the Asante Foundation also helps support numerous clinical departments at RRMC. This includes a generous donation of over \$71,000 to the Hospice department, \$14,000 to the Social Services department, and \$98,500 to the Francis Cheney Family Place. The Inpatient Rehab Department received \$10,000 of donations and the Infection Prevention Department received

\$20,000 during the fiscal year. Other donations help support the Women's Imaging Center, the Emergency Department, the Mental Health department, and the Dubs Cancer Center.

Form 990, Part III, Line 4b - Program Service Accomplishments

The Asante Foundation's second largest program service accomplishment is the granting of \$214,689 to help support various departments and capital projects at Three Rivers Medical Center (TRMC), a 125 licensed bed hospital located in Grants Pass, Oregon.

During the tax year, the Foundation contributed over \$114,000 toward the purchase of a Stereotactic Breast Biopsy machine. This computer guided biopsy system enables a radiologist to obtain a breast biopsy specimen utilizing two dimensional images. The Foundation also made contributions of over \$29,400 to purchase 3 vein viewers for the Medical Nursing floors.

In addition to capital projects, the Foundation contributed over \$71,000 in general operating donations. This includes a \$23,000 to the Family Birth Center, \$24,400 to the Three Rivers Family House, and \$17,000 to the Spears Cancer Center. Other departments that benefited from Foundation donations include the Emergency Department, the Imaging Department, and the Diabetes Care Center.

The Asante Foundation's third largest program service accomplishment was applying for and receiving significant grants from various philanthropic foundations around the country.

During the year, the Foundation utilized a \$23,500 grant from the Kohl's "Fit Kids" project to launch a media campaign to encourage healthy eating and exercise for children.

The Foundation, in conjunction with the Connie Fiske Foundation, contributed over \$26,300 to subsidized the cost of mammograms. Donations from the Connie Fiske Fund allowed 180 women at the Women's Imaging Center at RRMC and 265 women at TRMC to receive subsidized mammograms. Most would not have received mammograms if not for the generous support of the Connie Fiske Foundation.

Also, The Foundation, partnering with the Regence Foundation, committed over \$51,600 to cover the costs of conferences and education for nurses and other medical personnel to learn more about palliative care and pain management.

Finally, the Asante Foundation has made donations to the Asante Chaplain Services, as well as granting scholarships to nursing students at Rogue Community College. In all, the Asante Foundation granted \$101,529 to the various other programs that help support Asante.

The Asante Foundation's on-going mission is to continually assess the needs of both hospitals it supports, as well as the community we serve. Over the years, the Foundation has contributed millions of dollars to help subsidized important clinical departments of the hospitals and help purchase needed medical equipment. It has also made significant contributions to major building projects at Rogue Regional Medical Center and Three Rivers Medical Center.

Once all reviews and corrections are made, the CAFO will sign all appropriate returns for filing. The return will then be filed either electronically or paper copy with the appropriate government agencies. A copy of the return is to be kept in Asante's Accounting department and another will be kept at Asante's corporate headquarters for public display and copying, as requested.
