THE HOSPITAL PROVIDES PEDIATRIC PATIENT CARE, MEDICAL RESEARCH, TEACHING OF PEDIATRIC RESIDENTS AND OTHER HEALTHCARE PROVIDERS, AS WELL AS ADVOCACY FOR CHILDREN IN THE PACIFIC NORTHWEST. THIRTEEN YEARS OF "FORES" HAVE PUT THE FRIENDS OF COSTCO GUILD ON THE LEADERBOARD AS SEATTLE CHILDREN'S HOSPITAL'S LARGEST SINGLE FUNDRAISER. IN 2012, THE FRIENDS OF COSTCO GUILD HELD ITS THIRTEENTH ANNUAL CHILDREN'S GOLF CLASSIC, A GOLF TOURNAMENT, WHICH RAISED FUNDS PRIMARILY BENEFITING THE UNCOMPENSATED CARE PROGRAM OF THE HOSPITAL.
