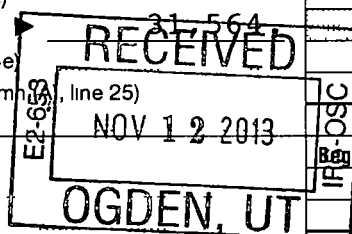

Environment:

In Haiti, 40% of a family's income is spent on charcoal used for cooking. We helped International Lifeline Fund establish Haiti's first charcoal-efficient stove business. Each stove cuts the amount of charcoal needed in half, and drastically reduces carbon and smoke emissions-improving health and the environment. We helped Lifeline sell approximately 3,252 charcoal efficient stoves in 2012. This project is estimated to impact 16,260 individuals.

4b (Code) (Expenses \$ 89,353. including grants of \$ 71,000.) (Revenue \$)

Water:

With one third of all freshwater wells broken, we are working with Water for People to train approximately 148 people to become well mechanics in India to provide water maintenance to wells. This project is estimated to provide 740,000 people with a sustainable water supply.

4c (Code) (Expenses \$ 36,282. including grants of \$ 28,830.) (Revenue \$)

Hunger:

80% of the poor in Sub-Saharan Africa work as subsistence farmers, yet 75% of their children go hungry. We support 5 Kickstart International sales reps that travel to remote rural villages in Kenya selling affordable irrigation pumps. Each pump can move a farmer and his or her family from poverty into the middle class in one harvest. The sales reps are estimated to sell 72 pumps, which are estimated to help 360 individuals out of poverty forever.
