FINANCIAL SUPPORT FOR THE PROGRAMS AND SERVICES OF THE HUMANITIES CENTER COMES FROM THE NATIONAL ENDOWMENT FOR THE HUMANITIES, THE STATE OF MINNESOTA, PRIVATE AND CORPORATE FOUNDATIONS, INDIVIDUALS, AND REVENUE EARNED FROM FEES AND CONFERENCE CENTER RENTALS. PAUL, LEARNING LAW AND DEMOCRACY FOUNDATION, AND THE MINNEAPOLIS YMCA'S YOUTH IN GOVERNMENT PROGRAM, AND PROVIDED FUNDING TO DESIGN AN EMERGING VETERAN'S VOICES PROJECT.
