THE VICE CHAIR OF THE BOARD RECEIVES THAT REPORT AND DISCUSSES IT WITH HIS/HER FELLOW COMMITTEE MEMBERS, AS WELL AS THE PRESIDENT. AT THE FALL MEETING OF THE BOARD, IN EXECUTIVE SESSION, THE COMMITTEE MAKES A RECOMMENDATION TO THE BOARD REGARDING COMPENSATION, WHICH THE BOARD ADOPTS.

THE FEDERATION OF STATE HUMANITIES COUNCILS PUBLISHES A SALARY SURVEY ANNUALLY, WHICH THE BOARD CONSIDERS AS PART OF ITS DETERMINATION OF EXECUTIVE COMPENSATION. OTHER FACTORS INCLUDE EMORY UNIVERSITY COMPENSATION POLICIES, AS THE GHC IS AN AFFILIATE OF EMORY.
