Lincoln County Farm Bureau sponsored the Lincoln County Legislative Dairy Breakfast. Board member Debby Bardwell along with several other county members attended the meeting with local officials and legislators. ☐

Lincoln County 4-H Sale of Champions. Lincoln County Farm Bureau participated in the Lincoln County 4-H Sale of Champions at the Lincoln Civic Center. This event gives the children an opportunity to show their livestock and reveal the results of hard work and dedication at home and on a farm. Approximately 75% of the participants are members of a Lincoln County Farm Bureau family. Lincoln County Farm Bureau has made it a priority to support agriculture and the youth of Lincoln County. The 4-H Sale of Champions provides education opportunities in agriculture through livestock projects. The sale also provides scholarship money for the youth. Lincoln County Farm Bureau is the largest contributor to the Sale of Champions. Several members of our Farm Bureau Board of Directors were present to lend Farm Bureau support to these kids. Directors Larry Sasser and Perry Spencer were on hand to bid on behalf of the county Board of Directors. Lincoln County Farm Bureau recognizes the need for the continued support of these fine young people and pledges to do all they can to further benefit the organization of the Lincoln County 4-H and the students.

Lincoln County Farm Bureau Board of Directors awarded four scholarships again this year. Each scholarship recipient was awarded \$1000 each. Applicants are required to live in Lincoln County and their families be a member of Lincoln County Farm Bureau. Preference is given to students majoring in an agriculture or forestry related field, although all interested students are encouraged to apply. Lincoln County Farm Bureau Federation has established these scholarships as part of their continuing endeavor to promote education and assist worthy college bound students demonstrating financial need. On June 18, 2012 before the business meeting of the Lincoln County Farm Bureau Board of Directors a small reception was held for these recipients and their parents. The participation in the application process has grown significantly during the past few years due to the publicity about the scholarships.
