SINCE 2006, THE NEW MEXICO HUMANITIES COUNCIL HAS TAKEN A LEADERSHIP ROLE IN COMMEMORATING THE 100TH ANNIVERSARY OF STATEHOOD IN NEW MEXICO WHICH OCCURRED ON JANUARY 6, 2012. DURING THIS TIME THE NMHC AWARDED MORE THAN 64 CENTENNIAL GRANTS AND 8 COUNCIL CONDUCTED-INITIATIVES TOTALING 682,275. THESE GRANTS SPECIFICALLY ADDRESS, EXPLORE, COMPARE AND CONTRAST, AND DISCUSS CONCEPTS RELATING TO THE DEVELOPMENT AND MEANING OF THE NEW MEXICAN IDENTITY OVER TIME IN ORDER TO BETTER UNDERSTAND WHO TODAY'S NEW MEXICANS ARE. THE NEW MEXICO HUMANITIES COUNCIL IS ALSO THE STATE SPONSOR FOR NATIONAL HISTORY DAY, A YEAR-ROUND PROGRAM THAT ASSISTS STUDENTS IN GRADES 6-12 TO CREATE HISTORY PROJECTS BASED ON IN-DEPTH RESEARCH ON AN ANNUAL THEME. THE NMHC SENT 61 STATE CONTEST WINNERS TO COMPETE IN THE NATIONAL FINALS IN COLLEGE PARK, MARYLAND. A NUMBER OF THE NEW MEXICO ENTRIES ADVANCED ONCE AGAIN TO THE NATIONAL FINALS, WHERE 1ST, 2ND, AND 3RD PLACE MEDALS WERE AWARDED IN FIVE DIFFERENT CATEGORIES. THREE STUDENTS FROM ALBUQUERQUE WON 2ND PLACE IN THE "MID-SCHOOL EXHIBITION" CATEGORY.
